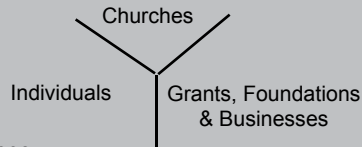

Executive Director's Report

Thank you for your contributions in 2008. Whether by donation or participation in a fund raiser, we appreciate your involvement. Your gifts helped us make it through a difficult financial year. Unfortunately financial stress on families causes distress and the need for our services in the family courts intensifies.

2008 got off to a busy start when we learned that we were one of four sites in the nation chosen to

participate in a project to improve outcomes for children placed in foster care. NewDay was chosen because of its successful fatherhood program, its relationship with the Fatherhood Coalition of Tarrant County and our existing presence in the courts. Best practices from this project will eventually

be legislated on and become policy throughout the nation, thus positively impacting children's lives.

Simply put, NewDay does not just treat symptoms. Whenever possible, we reach families and children before they are in trouble. In 2008, aside from meeting one-on-one with divorcing couples at the Family Law Center and adolescents at the Juvenile Justice Center, we conducted marriage strengthening

classes, marriage preparation classes, responsible fatherhood classes and character-building classes. These programs impacted not only the participants but the lives of their families as well. Without your donations, this could not happen!
